Province Approves Bruderheim Annexation

The Town of Bruderheim and Lamont County Councils are pleased to announce the Province of Alberta has approved the annexation of approximately 197 ha of land to the east and south of Bruderheim's current town limits.

Annexation negotiations began in May 2014, with Lamont County and the Town of Bruderheim collaborating on hosting open houses to seek feedback as well to answer the questions of affected landowners.

"Lamont County Council worked closely with the Town of Bruderheim during the annexation process, and we are satisfied with the final outcome. We hope that the residents involved in the annexation will benefit from the agreement, and will be happy in the Town of Bruderheim," says Reeve Wayne Woldanski.

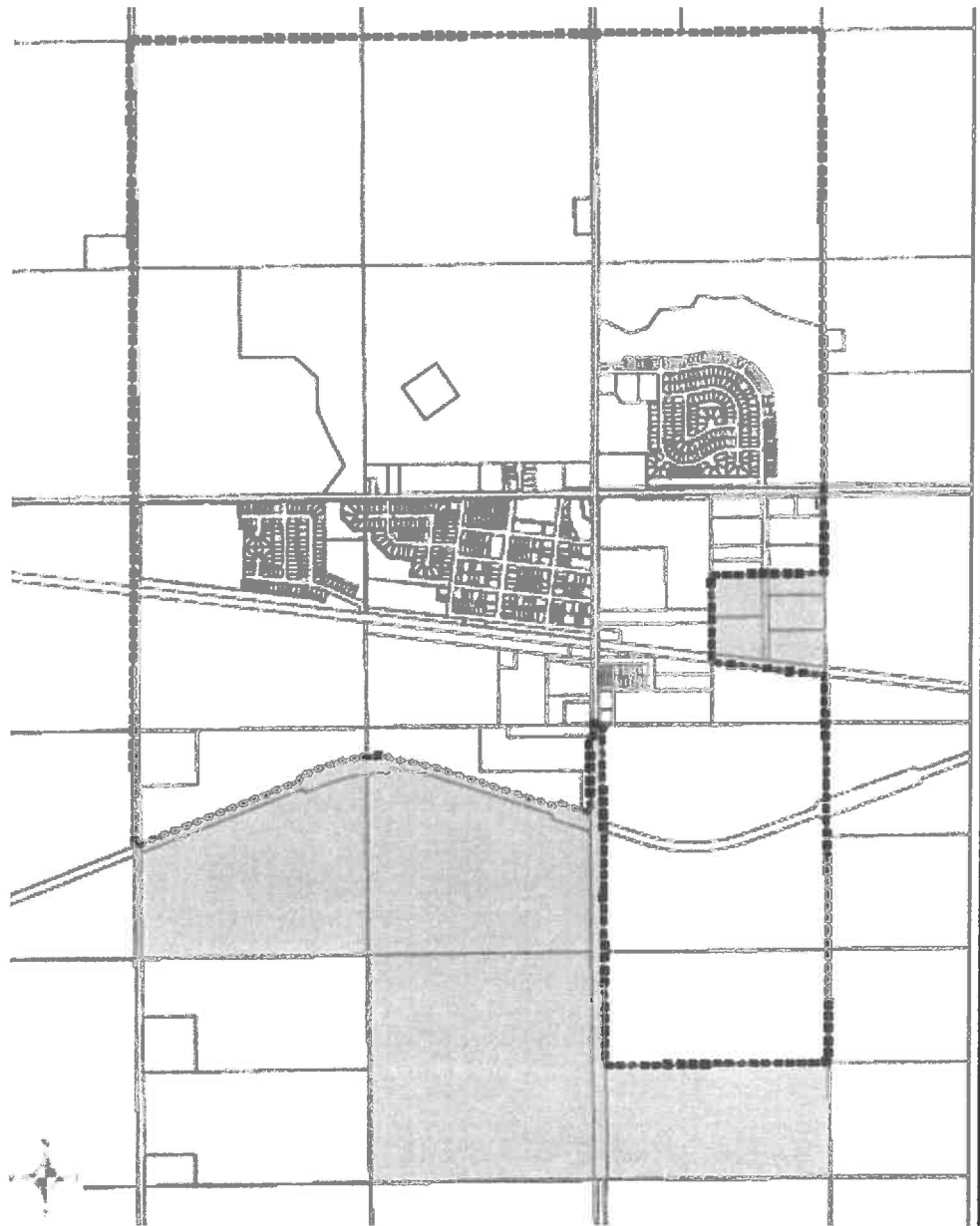

LAMONT COUNTY AND ANNEXED TO THE TOWN OF BRUDERHEIM**

ALL THAT PORTION OF THE WEST HALF OF SECTION THIRTY-THREE (33), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BRUDERHEIM.

ALL THAT PORTION OF THE SOUTH HALF OF SECTION THIRTY-TWO (32), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BRUDERHEIM.

THE NORTHEAST QUARTER OF SECTION TWENTY-NINE (29), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN.

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION TWENTY-EIGHT (28), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BRUDERHEIM.
