Purpose

To provide consistent guidelines for the annual rental and use of advertising spaces within the Karol Maschmeyer Arena.

Guidelines for Businesses and Sponsors

Businesses and sponsors may rent an identified advertising space within the arena. Priority will be given to Town of Bruderheim Businesses. The business and organizations that are advertising will be responsible for the cost of the sign. The town reserves and holds authority over inspection of all advertising and can remove or reject any advertising that may be offensive or if they receive complaints.

All signs must meet the following specifications:

"h" means the height of the sign

"I" means the length of the sign

"w" means the width of the sign

- Placement 1 (P1) Rink Board
 - o Twenty placements available
 - Minimum charge \$250.00 (plus GST)
 - o Maximum size: 3'h x 8'l x 1/8" w
 - o Waterproof paper or Foam Board
- Placement 2 (P2) Zamboni: Located on either side of the Zamboni
 - o Two placements available
 - o Minimum charge \$500.00 (plus GST)
 - o Maximum size: 24"h x 75" l x 3/16" w
 - o Foam Board

Renewal invoices will be sent out at the beginning of September each year.

An Advertising Rental Agreement (Schedule 'A') must be completed and applicable fees paid prior to the installation of the sign.

If a business fails to pay their rental invoice within the set terms the sign shall be removed by the Town and the Town is under no obligation to return the sign to the business.

Guidelines for Non-Profit Organizations

Non-profit groups may book an annual advertising space located in a non-prime location, without rental costs. The group that is advertising will be responsible for the cost of the sign. The town reserves and holds authority over inspection of all advertising and can remove or reject any advertising that may be offensive or if they receive complaints.

All signs must meet the following specifications:

"h" means the height of the sign "l" means the length of the sign "w" means the width of the sign

 - o Maximum size: 3'h x 8'l x 1/8" w
 - o Waterproof paper or Foam Board
